



# Correlation between physical health and behavioral health

### Physical and mental health drive one another - integrated healthcare is important.

- 29% of adults with a medical condition also have mental health disorders
- ✤ 70% of BH patients have a medical co-morbidity
- 3x more to treat physical health of patient with underlying BH issues

- **190 million** Americans have at least one chronic condition
- Over **30 million** Americans have three or more chronic conditions
- Multiple chronic conditions to increase to 83 million people by 2050
- 50 million adults are living with mental illness
- More than half don't receive treatment each year
- Spending on mental health hit **\$225 billion** in 2019

# Current state of mental health in America

- 21% 50 million adults have mental illness. Of these, 55% get no treatment.
- **4.8%** 12 million adults with serious thoughts of suicide. This has increased every year since 2011.
- **15%** 38 million adults with Substance Use Disorder. Of those 93.5% get **no treatment**.

- **11%** 5.5 million adults with mental illness are **uninsured**.
- 6.3% 1.5 million youth with an alcohol/illicit drug disorder in the past year.
- **16% 15 million youth** have major depression. 60% of them get **no treatment**. One in 10 youth with private insurance have **no MH coverage**.

# Current state of mental health in Kansas



In a 2023 Mental Health America survey, Kansas ranked last in the national mental health study. This was due to the high prevalence of mental disorders and low access to care.

#### 26.5%

560,000 adults have mental illness. **Rank 48/51**. National average is 20.78%.

- 6.4% 139,000 adults have serious thoughts of suicide. Rank 48/51. National average is 4.84%.
- **18.4%** 398,000 adults with Substance Use Disorder. Rank 46/51. National average is 15.35%.

- 9% of youth below age 21 are identified with SUD. Rank 51 of 51. National average is 6.3%.
- **17.5%** of adults with mental illness have no insurance. **Rank 48/51**. National average is 10.8%.
  - 6.5% of youth with severe depression get treatment. Rank 51/51. National average is 28.2%.

### Trends Substance use statistics

Among Americans aged 12 years and older, **37.3 million** are current illegal drug users.

If alcohol and tobacco are included, **195 million** Americans aged 12 years or older currently use drugs.


- ◆ 138.5 million Americans aged 12 and over drink alcohol.
- ◆ 28.3 million of these, or 20.4%, have an alcohol use disorder.
- ✤ 57.2 million people use tobacco or nicotine.
- 9 million, or 25.4%, of illegal drug users have a drug disorder.
- Over 2 million people, or 24.7%, of those with drug disorders have an opioid disorder. This includes prescription pain relievers and heroin.
- Accidental drug overdose is a leading cause of death among persons under the age of 45.
- 17 million U.S. adults experienced both mental illness and substance use disorder (National Survey on Drug Use and Health, 2020).

# Suicide rates higher than national average

Half a million lives have been lost to suicide since 2010, a serious public health concern.

In 2020, suicide was the **second leading cause of death** among adolescents (ages 12-17) across the U.S.





Trends COVID-19 impact on mental health

- 4 in 10 adults reported anxiety and/or depression in early 2021, declined to 3 out of 10 as pandemic continued.
- Increased substance use and drug overdose deaths from 70,630 deaths in 2019 to 106,600 in 2021.
- This increase disproportionally impacts people of color.
- Opioid overdoses represent 75% of these deaths, accelerated during pandemic and with increase in fentanyl.
- Increase in suicide deaths seen in 2021 (48,183 deaths) after decrease pre-pandemic in 2018 and 2019.
- Suicide deaths have increased fastest among people of color, younger individuals, and people who live in rural areas.
- Risk factors can include isolation, relationship struggles, financial or housing insecurity, or problems with physical health.

### Trends Social determinates of health

Large shares of people are experiencing hardship.

- Nearly one in three adults reported symptoms of depression or anxiety.
- More than one in eight adults reported that they or someone in their household had experienced a loss of employment income in the past four weeks.
- More than six in ten adults reported at least a little difficulty paying for usual household expenses in the last 7 days.
- ♦ 7% of adults had no confidence in their ability to make next month's housing payment.
- ✤ 10.3% of adults report food insufficiency in their household.

Trends Child and adolescent mental health

Child and adolescent mental health awareness has been on the rise related to the COVID-19 pandemic.

Factors such as isolation, inadequate socialization, changes in routines, and stress on the family unit due to sickness or job loss have increased behavioral health concerns among this population.

The U.S. Surgeon General called the current situation "unprecedented," and pediatricians have declared a **national mental health emergency**.

### The CDC's Adolescent Behaviors and Experience Survey COVID-19 factors that have a detrimental effect on mental health

- More than one in three high school students experienced poor mental health during the pandemic and nearly half of students felt persistently sad or hopeless.
- Female students and those who identify as lesbian, gay, bisexual, other or questioning (LGBQ) are experiencing disproportionate levels of poor mental health and suicide-related behaviors. For example, in 2021, 12% of female students, more than 25% of LGB students, and 17% of other or questioning students attempted suicide during the past year compared to 5% of their male peers and 5% of their heterosexual peers, respectively.
- More than half of students experienced emotional abuse in the home and more than 10% (20% LGB) reported physical abuse in the home.
- Black students were most likely to report hunger, with nearly a third reporting that there was not enough food in their home during the pandemic.







23-year-old female with depression & anxiety Seeking provider referrals
