

# Pathways to a Healthy Kansas





The Pathways to a Healthy Kansas initiative combines community-wide evidence-based solutions and promising practices for improving active living, healthy eating, behavioral health and commercial tobacco prevention to make a meaningful impact across multiple sectors in communities by addressing the social determinants of health and health equity. The program provides community coalitions with the tools and resources needed to engage their communities and remove barriers to healthy living.



- Increase awareness and community engagement in leading healthy lifestyles
- Make the healthy choice the default choice across sectors of the community through both policy and practice
- Increase consumption of and access to healthy foods
- Increase access to and use of safe environments for physical activity
- Support commercial tobacco-free living
- Improve behavioral health using a wholeperson health approach to reduce stigma and increase community connections.
- Improve quality of life now and continuing for generations to come

# **Upcoming Grant Cycle**

### PHASE 3

- Focus Areas: Healthy Eating, Active Living, Commercial Tobacco Prevention, Behavioral Health
- Pathways: Healthy People 2030 SDOH Model
- Funded Communities: 16-20 with Health Coalition Hub for non-funded coalitions
- Grant Period: 2 years w/standard RFA open period and invitation to apply starting in 2026
- \$100,000 competitive grant and additional noncompetitive implementation grant funds up to \$250,000 per community
- Focus on Health Equity

# **Pathways and Packages**

# **1**ECONOMIC STABILITY PATHWAY

This social determinant represents an individual's ability to access essential resources such as food, housing or healthcare. It also involves creating a healthy business culture to help an employer attract and retain talent, reduce absenteeism and turnover, and improve productivity. Pathways grantees will be required to engage partners to sign a Pathways pledge. Packages under this pathway include:

- ► Food Pantry/Food Reclamation
- Healthier Food Retail
- ► Healthier Restaurant
- Kansas Power of the Positive Family Friendly Workplaces
- ► Social Entrepreneurship Supports



## **EDUCATION ACCESS AND QUALITY PATHWAY**

This social determinant creates connections between education and health and well-being by promoting healthy lifestyles, creating supportive infrastructure and environments that enable educational attainment, language and literacy skills, and early childhood education and development. Pathways grantees will partner with early childhood centers, school districts, and/or higher education organizations to sign a Pathways Pledge and meet the minimum requirements related to the following packages:

- Farm to School or Child Care
- Healthier Higher Education Food Environment
- ► Healthier Child Care Facilities
- ► Substance Use Prevention in Schools
- Youth Physical Activity





This social determinant focuses on connecting access to healthcare, both physical and behavioral healthcare, and people understanding how health services <u>impacts</u> their own health. It ensures that healthcare organizations work to address factors that impact community health. Pathways grantees will be required to engage healthcare partners to sign a Pathways pledge and complete work related to the following packages:

- Community-Engaged Quality Improvement
- Community Health Needs Assessment/Health Improvement Plan Support
- ► Food Is Medicine
- ► Health Related Social Needs
- Healthier Hospital Food Environment
- Physical Activity Prescription Program
- Placemaking in a Healthcare Setting



# NEIGHBORHOOD AND BUILT ENVIRONMENT PATHWAY

This social determinant focuses on building connections between where a person lives (e.g., housing, neighborhood, and environment) and his or her health and well-being. Pathways grantees will be required to engage partners to sign a Pathways pledge. Potential packages under this pathway include:


- ► Community Planning

- ► Healthier Affordable Housing
- Multimodal Transportation and Recreational Trails

# SOCIAL AND COMMUNITY CONTEXT PATHWAY

This social determinant focuses on work at the community level to improve social integration, support systems, community engagement, and reduce stress and eliminate discrimination. Pathways grantees will be required to engage partners to sign a Pathways pledge. Potential packages under this pathway include:

- Community Resilience and Behavioral Health
- ► Healthier Communal Meals
- Health in All Policies
- Incubator Kitchen and Food Hub
- Placemaking



The Nutrition for Recovery Program is designed to provide balanced meals and nutrition education to people in recovery in a communal meal setting, so they can support and sustain their recovery. That program recently received a \$10,000 Pathways to a Healthy Kansas implementation grant, a Blue Cross and Blue Shield of Kansas (BCBSKS) initiative, in partnership with Heal Reno County and the Substance Abuse Center of Kansas (SACK), said Candace Davidson, Promotion Supervisor with the Reno County Health Department and with Heal Reno County. 

# **Four Years** of Impact

The Kiowa District Healthcare Childcare Center utilized a Pathways grant to install sunshades in the outdoor areas of the child center. This addition will enable children and staff to spend more time outdoors, enhancing playtime and promoting health.

The Medicine Lodge Peace Treaty Association (MLPTA) received a Pathways grant to install amenities to enhance the experience at the Intertribal Powwow Grounds and 5-Tribes Trailhead area. The Pathways funding also strengthened partnership efforts between BCU. MLPTA, the city and county by supporting engineering and environmental studies as well as policy work for a regionally impactful Transportation Alternative project, the Peace Treaty Connector Trail.

Kiowa Hometown Market (HTM) was awarded a Pathways grant to replace a decades-old meat cooler, allowing access to increased options of fresh fish and poultry to shoppers. Prior to receiving this funding. HTM was a key partner in Pathways projects at South Barber Food Bank. Kiowa District Healthcare and USD 255.

The City of Hardtner's park project engaged community members through community conversations to gather ideas for developing the space. The community voted on the installation of a professional disc-golf course, pet clean-up station and additional accessible seating. This transformation was made possible by community voices.

# **Four Years** of Impact

The Mitchell County Food Pantry received a Pathways grant to update their facility to better serve the needs of their clients. Grant funds were used to purchase new shelving, refrigeration and a freezer unit that will increase capacity to store and distribute fresher, healthier items.

The NCK Health Collaborative is humbled to be able to invest in several of our underserved rural communities. The City of Jewell. Burr Oak, Formoso and Mankato all received placemaking grants through the Pathways initiative to support physical activity and tobacco-free spaces.

Jewell County Strong received Pathways grant funding in recognition of their work to create a community recreation facility for Jewell County. The recreation facility will be the first in Jewell County and provide physical activity exercise opportunities with an intentional focus on supporting their senior population.

# From Voices to Victories:

The Impact of Community Engagement

The Mitchell County Food Pantry Hunger Relief Initiative surveyed food pantry clients around health barriers in relation to nutrition. Nearly 50% of clients reported struggling with chronic disease and many have limited access to household cooking appliances. This input provides a platform for advocating for healthier options with donors.

# NXTSTAGE

The 2024 program brought together seven community partners from leading Kansas health and economic-development organizations and 10 innovative finalists from around the world.

Finalist pitched, and the program partners committed to piloting solutions that tackle key challenges such as women's and maternal health, veteran career opportunities, holistic individual care, early skin cancer detection, citizen engagement, and gamified addiction recovery.

Since 2021, the competition has kick-started 55 local and statewide projects, and this year's program attracted **136** competitors from **31** states and **11** countries.
